## Construction Electrician/Construction Wireman\* in Los Angeles County (IBEW Local 11)

Rates effective May 27, 2024 through December 29, 2024

The parties to the MOU have concluded negotiations on the wage opener. Effective 5/27/2024, there will be an **\$0.80** increase to the CE-1 wage rate (with all other wage rates affected proportionately). Additionally, there will be an increase to the wage rate and health contribution on December 30, 2024. See below for details.

**Additional Information**

- (a) NEBF contribution is an amount equal to 3% of the gross wage.
- (b) NEIF contribution is an amount equal to 1% of gross wage and is paid by NECA members only. AMF amount paid by non-NECA only.
- (c) The minimum hourly rates of wages and benefits for Inside Journeymen, Foremen, General Foremen, and Apprentices shall be per the work site Local Inside CBA.
- (d) Other than an Inside Wireman, only a Construction Electrician Level 2 with a valid City, County and/or State License/Certification may be designated as a jobsite lead/foreman, whose wage scale will be as determined above, plus 10%.

**Future Increases:**

Wages:	Effective December 30, 2024 there will be a \$0.85 increase to the CE-1 wage (with all others affected proportionately). MOU expires on 5/31/25.
Health:	Effective December 30, 2024 the health contribution increases to the following rates: CW1 through CE = \$6.83 / hour CWA (1,000+ hours) = \$4.97 / hour

**Shifts:** Swing Shift = wage + 17.3%; Graveyard = Wage + 31.4% (See Section 3.12 of Inside Wireman Agreement)

\*\* **Los Angeles local terms:** Workers with the CW-A classification shall receive FMCP Plan 14 Single coverage after attaining 1,000 hours of work in the classification.
