## IBEW Local 11 Residential Wiring Agreement

Rates effective July 1, 2024 through December 29, 2024\*

The parties to the CBA have concluded negotiations on the wage opener. Effective 7/1/2024, there will be an **\$0.80** increase to the Residential Wireman wage rate (with all other wage rates affected proportionately). Additionally, there will be an increase to the wage rate and health contribution on December 30, 2024. See below for details.

- (c) To become a foreman must have Master Residential classification.
- (d) A Master Residential Electrician must work 2,000 hours and pass the following courses: Conduit bending Advanced, Transformers, and Motor Control Basics.

**Future increases:**

Wages:	There will be a \$0.85 increase effective 12/30/24. The CBA expires on 6/29/25.
Health:	Health increase 12/30/24 will be as determined by IBEW/NECA FMCP.

**Please note:** Double the straight-time rate of pay applies on Sundays and holidays, and after ten (10) hours work on any day.
